(1) Livewire is committed to ensuring that all personal data collected and used by Livewire is managed in accordance with the requirements of the Data Protection Act 1998.

(2) Where images are put into the public domain, their life is effectively 'indefinite', and in the case of the World Wide Web, effectively global and not limited to the United Kingdom. (\*\*See Online Privacy note).
